## **USA SOCCER MONTHLY EXECUTIVE SESSION BOARD MEETING MINUTES**

October 10, 2012

Call to Order: 7:48 p.m.

**Executive Committee Attendance**: Same.

**Approval of Minutes**: Reviewed and approved.

**Protest and Appeals**: Carlos discussed some of the recent coaching red cards, noting that most coaching problems fall squarely within USA rules. The *Ide* matter was discussed, and he was referred to FYSA/FSR for his complaints. He understands that he has to serve the suspension since the conduct was admitted, but his issue was the integrity of the official/written report.

The board discussed the use of ref assessments re coaching complaints about particular referees. The USA Board approved payment for referee assessments as requested by the referee liaison in all those circumstances where the referee liaison deemed it appropriate, regardless of whether it was driven by coaching complaint or otherwise.

**Old Business**: Linda previewed the website in the general meeting.

**New Business:** 

The Everton referee fee issue was discussed where the game was cancelled on 2 occasions

without notice to the USA assigned referee. Final demand for payment to be sent.

15 day rule re rescheduling of games was discussed and the problems that have been

encountered. Further discussion held until the next meeting as to resolution of the unplayed

games.

Carlos is going to submit a suggested referee payment schedule for the next year.

The board approved T-shirts & medals, as appropriate, for all division winners. The cost was

estimated to be well less than \$10,000. Though not reflected in the budget, the consensus was

that we had indeed approved it after the complaints following last season when we

discontinued it.

A special executive session was scheduled to follow the meeting to discuss the use of

uncertified referee assignors by one or more affiliate clubs.
